Commissioner Bauder seconded and the motion carried 3-0.

Commissioner Bauder moved to award the bid for the purchase of a water conservation system and plumbing supplies for the Logan County Jail to I-Con in the amount of \$74,565.18. Commissioner McBride seconded and the motion carried 3-0.

A RESOLUTION ADOPTING THE AMENDED SPECIAL FLOOD HAZARD AREAS IDENTIFIED BY THE FEDERAL EMERGENCY MANAGEMENT AGENCY, AND THE ASSOCIATED FLOOD INSURANCE RATE MAPS, FOR INCLUSION IN SECTION 7.7, ARTICLE III., B. OF THE LOGAN COUNTY ZONING RESOLUTION.

WHEREAS, the Board of County Commissioners of Logan County is, pursuant to C.R.S. § 30-28-116 and Section 11.1 of the Logan County Zoning Resolution, authorized to adopt zoning regulations and to amend existing zoning regulations; and

WHEREAS, the Board of County Commissioners of Logan County, upon the recommendation of the Colorado Water Conservation Board and Federal Emergency Management Agency (FEMA), has determined that Section 7.7, Flood Damage Prevention Regulations, Article III, Section B, <u>Basis For</u> <u>Establishing The Special Flood Hazard Area</u>, should be amended as shown in bold-type below to reflect updated Flood Insurance Rate Maps:

The Special Flood Hazard Areas identified by the Federal Emergency Management Agency in a scientific and engineering report entitled, "The Flood Insurance Study for Logan County, **Colorado and Incorporated Areas**," **effective May 4, 2021, and** with accompanying Flood Insurance Rate Maps (FIRM) and any revisions thereto, are hereby adopted by reference and declared to be a part of these regulations. The Special Flood Hazard Areas identified by the Flood Insurance Study (FIS) and attendant mapping are the minimum area of applicability of these regulations and may be supplemented by studies designed and approved by the Logan County Planning and Zoning Department. The Floodplain Administrator shall keep a copy of the FIS, DFIRMs, FIRMs and/or FBFMs on file and available for public inspection.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Logan County, Colorado, that Section 7.7, Flood Damage Prevention Regulations, Article III, Section B, <u>Basis</u> For Establishing The Special Flood Hazard Area, is hereby amended to read in its entirety as follows:

SECTION B. BASIS FOR ESTABLISHING THE SPECIAL FLOOD HAZARD AREA

The Special Flood Hazard Areas identified by the Federal Emergency Management Agency in a scientific and engineering report entitled "The Flood Insurance Study for Logan County, Colorado and Incorporated Areas," effective May 4, 2021, and with accompanying Flood Insurance Rate Maps (FIRM) and any revisions thereto, are hereby adopted by reference and declared to be a part of these regulations. The Special Flood Hazard Areas identified by the Flood Insurance Study (FIS) and attendant mapping are the minimum area of applicability of these regulations and may be supplemented by studies designed and approved by the Logan County Planning and Zoning Department. The Floodplain Administrator shall keep a copy of the FIS, DFIRMs, FIRMs and/or FBFMs on file and available for public inspection.

RESOLUTION

No. <u>2021-15</u>

WHEREAS, Logan County is a legal and political subdivision of the State of Colorado for which the Board of County Commissioners ("Board") is authorized to act; and

WHEREAS, Logan County contains about 1,181,760 acres of land situated in Northeastern Colorado; and

WHEREAS, the federal government owns approximately .03 % of the land within the County, and the Bureau of Land Management, United State Forest Service, and Department of Defense are responsible for managing 306 acres of these federal lands as illustrated in Exhibit A, attached hereto; and

WHEREAS, conserving lands does not assure its preservation. Left in an undisturbed or natural state, these lands are highly susceptible to wildland wildfires, insect infestation, and disease, all of which degrades the natural and human environments; and

WHEREAS, the wellbeing, health, safety, welfare, economic condition, and culture of the County, its businesses, and its citizens depend on private land ownership and the use of these lands; and

WHEREAS, many of Logan County's businesses and citizens are involved in or otherwise depend on commerce that utilizes private lands and their resources, including crop production, livestock grazing, natural gas production and the royalties property owners receive from this production, mining, and mineral development, outdoor activities including hiking, biking, hunting, fishing, boating, gardening and other outdoor recreation; and

WHEREAS, this commerce is an important component of the Colorado economy, and is a major contributor to the economic and social wellbeing of Logan County and its citizens; and

WHEREAS, on January 27, 2021, President Joseph R. Biden, Jr., issued Executive Order 14008 entitled Tackling the Climate Crisis at Home and Abroad (86 Fed. Reg. 7,619); and

WHEREAS, in Section 216 of Executive Order 14008, President Biden directed the Secretary of the Interior, in consultation with the Secretary of Agriculture and other senior officials, to develop a program to conserve at least 30 percent of the lands and waters in the United States by 2030, which is called the "30 x 30" program; and

WHEREAS, under the 30 x 30 program, some 680 million acres of our Nation's lands would be set aside through conservation, preventing the productive use of these lands and their resources; and

WHEREAS, there is no constitutional or statutory authority afforded to any President, the Department of the Interior, the Department of Agriculture, or any other federal agency to set aside and permanently conserve 30 percent of all land and water in the United States, and no such authority is referenced in Executive Order 14008; and

WHEREAS, placing private lands into permanent conservation status will cause a dramatic and irreversible harm to the economies of many states, including Colorado, and in particular rural counties such as Logan County, whose citizens depend on private lands for their livelihoods and recreation; and

WHEREAS, Executive Order 14008 at 216(a) directs the Secretary of the Interior, in consultation with other relevant federal agencies to "submit a report to the Task Force within 90 days of the date of this order recommending steps that the United States should take, working with State, local, Tribal, and territorial governments, agricultural and forest landowners, fishermen, and other key stakeholders, to achieve the goal of conserving at least 30 percent of our lands and waters by 2030."

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Logan County, Colorado, that:

- 1. The Board opposes the 30 x 30 program, including its objective of permanently conserving 30 percent of the Nation's lands and waters in its natural state by 2030, or any similar program that will set aside and prevent the productive use of millions of acres of our lands.
- 2. The Board further opposes the designation of lands in Logan County as wilderness, wilderness study areas, wildlife preserves, open space, or other conserved lands, thereby restricting public access to such lands and preventing the development and productive use of the resources on or within such lands.
- 3. The Board supports the continued private ownership of land in the County, recognizing the Nation's need for domestic sources of minerals, energy, timber, food, fiber, and recreation.
- 4. The Board recognizes and supports the State of Colorado's and private water rights system, including the State of Colorado's Statutes and regulations and programs governing water rights and water use, and opposes any federal designation of waters and watercourses within the State and County that would impair or restrict water diversions and uses authorized under Colorado law.
- 5. The Board supports reasonable national, regional, and global greenhouse gas emissions policies and goals that are comprehensive, practical, cost-effective, non-draconian, and do not unnecessarily single out specific industries or activities, but opposes the use of global climate change as a reason to set aside large tracts of land as conservation lands to fulfill the 30 x 30 program's objectives.
- 6. The Board also maintains that any lands or other rights that are acquired to fulfill the 30 x 30 program's objectives should be acquired only from willing landowners and for the payment of full and fair market value for all rights and interests acquired, and not through eminent domain or any other regulatory compulsion, and only after analyzing and considering the impacts of such land acquisitions on the well-being, health, safety, welfare, economy, and culture of Logan County, its businesses, and its citizens.
- 7. The Board shall send a copy of this Resolution to the Department of Interior and all other relevant Federal and State agencies.

WHEREAS, every child deserves the security of a stable, loving, and nurturing home. During National Child Abuse Prevention Month, we recognize the importance of all Americans working together each day in defense of the most vulnerable among us — our children. We must make every effort to ensure that they are treated with dignity and respect, and have the opportunity to pursue their dreams in secure and healthy environments; and

WHEREAS, the relationships that children have with parents, family members, teachers, and other caregivers profoundly shape their lives. When they are subjected to abuse and neglect, they are exposed to toxic stress that can disrupt early brain development and increase the risk of depression, suicide, substance abuse, developmental disabilities, future violence, juvenile delinquency, and other unhealthy behaviors. These and other devastating effects of child abuse can last a lifetime, and can even affect future generations; and

WHEREAS, as a County, we must do everything within our power to stop child abuse and neglect before they occur. The best defense against these menaces is a strong family led by loving and caring parents. Our community has a broad vision for strengthening families, which includes raising awareness, focusing on prevention, and working to help parents and children thrive. Family Resource Center offers the Colorado Community Response Program - an important step in helping move child welfare to a more preventionbased system. WHEREAS, we cannot lose sight of the importance of the entire community in preventing child abuse and neglect. But we also must acknowledge the friends, neighbors, educators, and faith leaders who help in promoting the well-being of children. And we extend our deepest respect and gratitude to the professionals, volunteers, and organizations who work tirelessly to protect at-risk children and to care for those who have tragically experienced the traumas of abuse or neglect; and

WHEREAS, we pray for all those who have suffered from the terrors of child abuse and neglect and who continue to suffer from its devastating psychological and physical impacts. We honor the courageous survivors of abuse and neglect and hold in our hearts those cruelly taken from us. We strengthen our resolve to eradicate abuse and neglect from our homes and community, and we pledge our unwavering commitment to preserving the innocence and safety of our children. Let us all strive each day to build a brighter future for them and for our county; and
