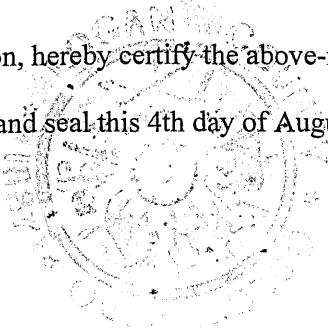
In accordance with the provisions of Colorado Revised Statute, section 1-12-111 (1), notice is hereby given that a recall election will be held for residents in the Buffalo School District RE-4J for Director District A, in said counties of Logan, Morgan & Washington, State of Colorado, on Tuesday the 8<sup>th</sup> day of November 2022.


The recall election will be conducted as a mail ballot election combined with the November 8, 2022; General Election pursuant to Colorado Revised Statute 1-12-111 (2).

**Successor nomination petitions** must be signed by at least 25 valid active electors of the Buffalo School District RE-4J. The nominations must be for a specific seat (Director District A) on the school board. Blank nomination petitions are available at the Logan County Clerk's Office, 315 Main Street, Suite 3, Sterling, CO 80751. Deadline to file is September 2, 2022. Colorado Revised Statute 1-12-117.
