

CLUSTER DEVELOPMENT APPLICATION REQUIREMENTS

Parcels of less than 35 acres can be created at a rate of 2 per 35 acre increments of the total acreage.

These parcels can only be used for single family residential purposes.

At least two-thirds (2/3) of the total acreage must be set aside as open space for a minimum of 40 years.

The process is initiated with an informal conference between the Landowner and the County Planner. Landowners shall submit a Preliminary plan and it's supporting documents to the Planning Commission and Board of County Commissioners prior to the submission of a Final Plat. Approval of the Preliminary Cluster Development Plan shall be effective for 12 months. The Final Cluster Development Plan must be applied for within this 12-month period unless an extension has been granted by the Logan County Planning Commission.

A Preliminary Cluster Development Plan must be submitted to the Department of Planning & Zoning at least **40 days** prior to the regularly scheduled Planning Commission meeting. The Planning Commission meets the third Tuesday of each month. **NOTE:** The Applicant, or a Representative, **MUST** be present at the public hearing and the Commissioner's meeting. If no one is present, the request will be postponed until the next meeting!

- 1. The following items must be provided with this application.
 - o \$100.00 Application Fee
 - \$43.00 Recording fee- (Separate Check)
 - An 18"x 24" or a 24"x 36" Preliminary survey plat, and an 8.5"x 11" copy, prepared by a
 Registered Surveyor in the State of Colorado. If the Board of County Commissioners grant approval,
 the plat and Resolution will be recorded in the Clerk's Office.
 - o A current copy of the deed, to prove ownership.
 - A Certificate of Taxes showing all taxes applicable to such land for years prior to that year have been paid.

2.	The Applicant must provide a Preliminary Cluster Development Plan. The Preliminary Cluster

- 3. The Planning & Zoning Department will publish a Notice of the public hearing regarding the Cluster Development request in the Sterling Journal Advocate, **30 days** prior to the hearing. <u>The Applicant</u> will be invoiced directly for the cost of the advertisement.
- 4. The Applicant will be required to post a Notice of Public Hearing Sign on the property, **14 days** prior to the hearing date. See Attached (sign regulations). A photo of the sign must be provided to the Planning and Zoning Department.
- 5. The Planning & Zoning Department will send written notice of the hearing to adjacent landowners within 500 feet. Failure to mail such notice shall not affect the validity of any hearing.
- 6. The Applicant is responsible for <u>"Making his or her Case"</u>. Visual representations are helpful in the review process. Additional maps, photographs, and other visual aids should be provided when possible.

LOGAN COUNTY CLUSTER DEVELOPMENT APPLICATION SIGN REQUIREMENTS

A sign must be posted when applying for any Land Use Application which involves a public hearing. The purpose of this requirement is to notify the public of the date, time and place of the Public Hearing and to inform the public of the Type of Land Use Application.

Sign requirements are as follows:

- The sign must be posted at least **14 days** before the Public Hearing date.
- The sign must be posted on a board such as plywood. The board must be at least 3'x4'
 and must be sturdy.
- The sign must be **4 feet above the natural grade** of the ground.
- The lettering must be at least **2 inches** in size.
- The sign must be posted in a conspicuous location on the property in question. **The sign** must be visible from the public road.
- The Applicant must provide the Planning Department with a **photograph of the sign** at the location where it is displayed.
