

CONDITIONAL USE PERMIT RENEWAL REQUIREMENTS

All Conditional Use Permits are subject to review and must remain in compliance with Logan County and the State of Colorado Regulations. All Permits must be reviewed and renewed every 99 years, unless otherwise stated on permit.

The application and required items must be received by the Planning and Zoning Department at least **20 days** prior to the regularly scheduled Planning Commission Hearing. The Planning Commission meets the third Tuesday of each month. **NOTE:** The Applicant, or a Representative, **MUST be present** at the Public Hearing and the Commissioner's Meeting. If no one is present, the request will be postponed until the next meeting.

- 1. Applicants must schedule a meeting with Logan County Planning and Zoning to ensure that all conditions established at the issuance of the original, or any modifications to subsequent renewals have been met.
- 2. \$100.00 Application Fee
- 3. The Applicant is responsible for "<u>Making his or her Case</u>". It is not the responsibility of the Planning and Zoning Department. Visual representations are helpful in the review process. Additional maps, photographs, and other visual aids should be provided when possible.
