Commissioner McBride seconded, and the motion carried 3-0.

There being no further business to come before the Board, the meeting adjourned, at 9:46 a.m.

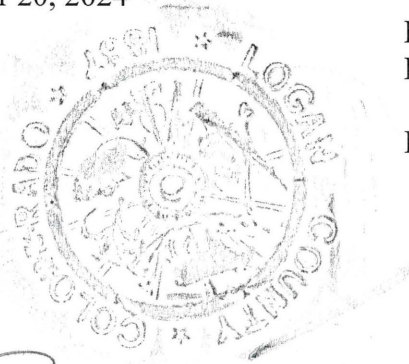


