A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LOGAN COUNTY, COLORADO, ADOPTING MODIFIED AMBULANCE SERVICE FEES FOR THE LOGAN COUNTY AMBULANCE SERVICE.

WHEREAS, Logan County and the City of Sterling have an intergovernmental agreement which provides for the joint funding and provision of emergency medical services in Logan County; and

WHEREAS, the intergovernmental agreement authorizes Logan County to determine the fees applicable to the services provided, and to retain all of the revenue received therefrom; and

WHEREAS, the ambulance service fees previously established by the Board are significantly less than the ambulance service fees currently being charged by neighboring counties and do not reflect the ongoing economic realities of being able to staff, operate and maintain a sustainable ambulance service; and

WHEREAS, operating expenses also continue to increase significantly and the Board has determined that a fee increase is necessary and warranted in order to insure the continued financial viability of the ambulance service.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Logan County, Colorado, that the Logan County EMS Ambulance Service fee schedule is hereby adopted in the form attached hereto and shall apply to ambulance services provided by Logan County Ambulance Service on and after January 1, 2025.
