Memorandum of Understanding

This Memorandum of Understanding (MOU) is entered into on February 11, 2025 by and between the Family Resource Center, a Colorado _______ with an address of 120 Main Street, Sterling, CO 80751 ("FRC") and the Logan County Colorado, ("County"), collectively the "Parties," to-wit:

- A. The FRC owns an iPad containing an application which provides information about various community resources available to members of the public in Logan County, Colorado.
- B. The Parties desire for the Logan County to host a kiosk for the iPad at its Logan County Courthouse located at 315 Main St., Sterling, CO 80751 (the "iPad Kiosk"), so that members of the community may access the community resource application.
- C. The parties desire to memorialize the terms and conditions upon which the County will host the FRC's iPad Kiosk.

In consideration of the foregoing recitals, incorporated by this reference, and the mutual promises below, the Parties agree as follows:

- 1. The County shall determine a suitable placement for the iPad Kiosk in its Logan County Courthouse. The location of the iPad Kiosk shall allow reasonable access to members of the public during the Logan County's normal business hours.
- 2. The FRC shall own the iPad and iPad Kiosk and the County shall not be responsible for any damage to the iPad or iPad Kiosk.
- 3. The FRC shall be solely responsible for any data plans, maintenance and repair costs, and other costs association with the ownership of the iPad and iPad Kiosk.
- 4. The term of this MOU shall be for one year and shall renew automatically on this MOU's anniversary date.
- 5. Either party may terminate this MOU upon not less than thirty (30) days' notice to the other party.
- 6. The FRC releases and holds the County, the County's employees, governing body, agents, successors, and assigns harmless from any damages, injuries, claims, losses, and any other liabilities caused by the iPad or the iPad Kiosk.
- 7. Within a reasonable time after termination of this MOU, the FRC shall cause the iPad Kiosk to be removed from the Logan County Courthouse.
