Commissioner Donaldson seconded and the motioned carried 3-0.

The Board continued with the Consent Agenda items:

- Approval of the Minutes of the January 30, 2018 meeting.
- Acknowledgment of the receipt of the Landfill Supervisor's report for the month of January 2018.

Commissioner McBride moved to approve the Consent Agenda. Commissioner Donaldson seconded and the motion carried 3-0.

## Chairman Pelton continued with Unfinished Business:

Commissioner Donaldson moved to award the proposal for the tandem axle utility trailer to NW Equipment of Sterling, for a PJ model 14'x77" utility trailer for the amount of \$2,650.00. Commissioner McBride seconded and the motion carried 3-0.

Commissioner McBride moved to approve one (1) two ton 4x4 pickup truck with crew cab to

Transwest Chevrolet for a Ram 5500 crew cab chassis and utility body 4x4 model for \$55,978.00 which was the low bid. Commissioner Donaldson seconded and the motioned carried 3-0.

Commissioner Donaldson moved to award the proposal for two (2) 1/2 ton 4x4 pickup trucks to Transwest Chevrolet of Sterling, for two (2) Ram 1500 ST quad cab 4x4 models for \$25,898.00 each, a total of \$51,796.00. Commissioner Donaldson seconded and the motioned carried 3-0.

Commissioner McBride moved to approve the one (1) 3/4 ton 4x4 pickup truck with crew cab to Transwest Chevy, for a Ram 2500 Tradesman crew cab 4x4 model for \$28,436.00 which was the low proposal. Commissioner Donaldson seconded and the motion carried 3-0.

Commissioner McBride moved to approve right of way permit 2018-4 between Logan County and CenturyLink for use of the County's right of way along and under Herford Avenue for a 2" conduit with fiber. Commissioner Donaldson seconded and the motion carried 3-0.

Commissioner Donaldson moved to approve right of way permit 2018-3 an agreement between Logan County and CenturyLink for use of the County's right of way along and under CR 21, 19, 17, 38, 15 and trench along county roads 36 and 38. Commissioner McBride seconded and the motion carried 3-0.

The Board moved on to Miscellaneous Business/Announcements:

Commissioner McBride announced the County Court House will be lit in blue tonight to honor fallen El Paso, County, Sheriff's Deputy Micah Flick.
