## Logan County Commissioners Work Session July 2, 2019

Present: Joe McBride, Jane Bauder, Byron Pelton, Alan Samber, Valerie Richards, Kristan Lange, Jeff Rice, Jerry Casebolt, Rob Quint, and Jennifer Crow.

Chairman McBride called the meeting to order at 9:00 a.m.

**APPROVAL OF MINUTES FROM PREVIOUS SESSION** - Commissioner Pelton moved to approve the minutes of the June 25, 2019 work session as written. Commissioner Bauder seconded, Chairman McBride abstained as he was not present and the motion carried.

**ADDITION TO WORK SESSION AGENDA** - The Board will discuss repairs to the GMC Terrains in the Assessor's fleet.

**REVIEW LOGAN COUNTY DEPARTMENT OF HUMAN SERVICES SCHEDULE OF BILLS** - Valerie Richards met with the Board to review the Logan County Department of Human Services schedule of bills dated July 2, 2019. The Board approved all bills as presented.

**REVIEW LOGAN COUNTY SCHEDULE OF BILLS** - Kristan Lange met with the Board to review the Logan County schedule of bills dated July 2, 2019. The Board approved all bills as presented.

**REVIEW OF BUSINESS MEETING AGENDA** - The Board reviewed the Business Meeting Agenda for the July 2, 2019 meeting.

**ASSESSOR'S FLEET REPAIRS** - The Board discussed to the GMC Terrain in the Assessor's fleet. The gas door was damaged in a recent hail storm. There may be other repairs necessary from the latest hail storm. The county will not be paid by insurance for damages from the most recent storm as the cars received damage in the 2015 hail storm with damages being reimbursed by CTSI. The Board agreed to the repairs to the gas door and will ask the Assessor to obtain three bids for the repairs.

**LOGAN COUNTY AMBULANCE DEBT COLLECTION ASSIGNMENT** - Commissioner Pelton moved to approve assignment of a Logan County Ambulance debt collections account to Wakefield and Associates, the account number ending in 6001 and allow the Chairman to sign. Commissioner Bauder seconded and the motion carried 3-0.

FAIRGROUNDS LOUDSPEAKER - Jerry Casebolt discussed installation of a loudspeaker to make announcements on the vendor and carnival midway in the event of an emergency. Currently, there is no way to notify the public on the midway in the event of an emergency such as a tornado warning, etc. The sound system in the stadium cannot be heard on the midway. Logan County Fair Manager Todd Thomas contacted Jerry suggesting the county pay half of the loudspeaker system since there are other events held at the stadium throughout the year.

Todd Thomas and Chance Wright obtained a bid from Mega Music in the amount of \$5,856.82. It was suggested that this be budgeted for next year.

**SOUTH PLATTE RIVER LEVELS** - Jerry Casebolt reported that the South Platte River is

rising again but not by a large amount. The Atwood measuring station is reporting 5.67 feet right now, Flood stage is 7.2 feet. Trends are leveling off and starting to go back down today.

**MEETING ROOM PROJECTOR** - The Board discussed the projector in the meeting room. The wireless connection device that was purchased for the projector is not reliable in connecting to the projector. The projector is older and the wireless technology to connect computers to display is not working as it should. Jerry Casebolt has a portable projector which works with any platform. The projector can be used with any computer to display presentations on the screens.

The Board requested that the older projector be put back in place and also agreed that a new portable projector should be purchased for the meeting room.
