

**Logan County Commissioners Work Session
March 26, 2019**

Chairman McBride called the meeting to order at 9:00 a.m.

APPROVAL OF MINUTES FROM PREVIOUS SESSION - Commissioner Bauder moved to approve the minutes of the March 19, 2019 work session. Commissioner Pelton seconded and the motion carried.

REVIEW LOGAN COUNTY DEPARTMENT OF HUMAN SERVICES SCHEDULE OF BILLS - Valerie Richards met with the Board to review the Logan County Department of Human Services schedule of bills dated March 26, 2019. The Board approved all bills as presented.

REVIEW DEPARTMENT OF HUMAN SERVICES (DHS) APPROVAL OF PAYROLL Valerie Richards met with the Board to review the DHS approval of payroll for pay period March 2, 2019 through March 15, 2019. The Board approved payroll as presented.

LOGAN COUNTY LOGO - The new logo is ready to be rolled out. Marilee will share a Facebook post to unveil the logo. Computer files with color information will be sent out on Friday to various departments. Local T-shirt print shops will be sent color information to have available if people want to purchase items with the logo on a t-shirt emblem or patch.

ATV's/UTV's ON COUNTY ROADS - Commissioner McBride has received the City of Sterling's ATV/UTV rules and will share with the Board.

COURTHOUSE LIGHTING REPAIRS - Commissioner Bauder has reviewed the drawings for the Courthouse lighting. She has located ten 10 controllers of 5 different types. She has put in a call to Nate Webb to ask about the remaining controllers.

RESOLUTION OPPOSED TO SB 19-181 - Commissioner Bauder distributed a copy of a Morgan County resolution that she would like to schedule for the next meeting. The Board agreed to schedule the resolution for the next business meeting.

MENTAL HEALTH MEETING - Commissioner Pelton has been invited to participate and give input from rural Colorado on the Mental Health Crisis in a group along with Agriculture Commissioner Kate and former Agriculture Commissioner Don Brown to discuss ideas for resources to deal with the mental health crisis. The meeting is April 2, 2019. The Board agreed that Commissioner Pelton should attend.

INSPECTION OF LOGAN COUNTY JAIL - The Board will inspect the Logan County Jail. The Jail later reported the following population on March 23, 2019: Female Inmates 16; Male inmates 69; Out of County Male Inmates 4.
