

RECORD OF PROCEEDINGS

LOGAN COUNTY BOARD OF HUMAN SERVICES

May 10, 2023

Logan County Commissioner Chairman Jerry A. Sonnenberg called the Board meeting to order at 9:11 a.m. at the Logan County Central Services building with Logan County Commissioner Joseph A. McBride, Logan County Commissioner Mike Brownell, Logan County Human Services' Director David Long, and Logan County Human Services' Recording Secretary Peggy Kircher, present.

Minutes from the Board of Human Services meeting held on April 12, 2023 were presented. Commissioner McBride moved to approve the Board meeting minutes as written. Commissioner Brownell seconded the motion. The motion was approved.

Director Long presented the Board with the Expenditure Summary report dated April 30, 2023, the March Allocation Tracking report, and the TANF Reserve Balances reports dated March, 2023. Director Long said that the State is trying to figure out how to put the PRTFs, which are alcohol placements in residential treatment centers, in a different allocation line since it is 100% funded through Medicaid. This is currently showing as an expenditure in the child welfare allocation block. If they remove this from the CW allocation block, it will reduce the over expenditure to \$259,000.00.

Director Long requested that the Board approve the ability for Logan County DHS to enter into an agreement to purchase \$100,000.00 TANF funds from an undetermined county before the end of the State fiscal year, as needed. Commissioner Brownell moved to approve the upcoming purchase of TANF funds in the amount of \$100,000.00 and pay the associated MOE in the amount of \$15,000 before the end of the State fiscal year and authorize the Chair to sign. Commissioner McBride seconded the motion. The motion was approved.

Director Long gave the Board an overview of the CCCAP Intergovernmental agreements between Logan County and Kit Carson County and Logan County and Washington County. Commissioner Brownell moved to approve and authorize the Chair to sign the CCCAP Intergovernmental Agreements between Logan County and Kit Carson County and Logan County and Washington County for the purpose of Logan County DHS to determine the CCCAP eligibility for the current fiscal year ending June 30, 2023 and for the upcoming fiscal year July 1, 2023- June 30, 2024. Commissioner McBride seconded the motion. The motion was approved.

Director Long gave the Board the briefing highlights and staffing updates. Director Long informed the Board that LCDHS received Narcan from New Pathways due to them receiving a grant for the medication nasal spray. This is available at the department in the event a client comes into the building and needs it due to an overdose. The caseworkers also have Narcan available to use while out in the field working with the clients.

Director Long inquired about the status of the requests that were brought to the Personnel Board. Commissioner McBride said that the request to change the PTO/Family Leave policy was

denied. There are other requests that the Personnel Board is still working on and a final decision has not been made.

The next Logan County Board of Human Services meeting will be held on June 14, 2023 at 9:00 a.m. at the Logan County Central Services building.

There being no further business to come before the Board, the meeting was adjourned at 9:25 a.m.
