- Parking Attendant Services.



AGREEMENT TO USE LOGAN COUNTY RIGHT OF WAY
INDIVIDUAL PERMIT

THIS AGREEMENT made this (County fills in) 2nd day of May, 2024 by and between the County of Logan, State of Colorado, hereinafter called "County", and Hillrose Dairy L.L.C. the undersigned easement holder or landowner, hereinafter called "Applicant".

WHEREAS, Applicant owns the following described premises, or has an easement on, over or through said premises, to-wit (legal description): _____

WHEREAS, Applicant ~~desires~~ to install and construct a irrigation pipe line, which will be located (Circle One) along, bore under, or trench across Co Rd 18, to benefit the above described premises; and

WHEREAS, the County is willing to allow such installation and construction by Applicant, but only upon the terms and covenants contained herein.

NOW, THEREFORE, in consideration of paying the County the sum of \$100.00 or \$200.00 and keeping of the terms and covenants contained herein, the parties agree as follows:

- Applicant agrees to furnish the County in writing in advance of installation the exact location and dimensions of said installation and construction.
- Buried installations must be at no less than 48 inches below the lowest level of any borrow ditch paralleling the County Road and an "Individual permit" must be submitted for each instance.
- Applicant shall have the right to install and construct irrigation pipeline described above, in the right of way of Co Rd 18, but such installation and construction shall be done only in the following manner. All work within the county ROW shall be performed only during regular business hours of the Logan County Road & Bridge Department to enable supervision and inspection of the work.
- All work authorized by this Agreement shall be completed no later than June 31-2024.
- It is understood that no paved or oil-surfaced road shall be cut and will be crossed by boring only. For other roads and crossings of County property after installation. Applicant shall restore the surface to the same condition as existed prior to such construction.
- All cost and expense of installation, construction, maintenance, removal, or replacement is to be paid by the Applicant.
- The traveling public must be protected during this installation with proper warning signs or signals both day and night. Warning signs and signals shall be installed by and at the expense of Applicant.
- Applicant hereby releases the County from any liability for damages caused by said Hillrose Dairy L.L.C., whether caused by employees or equipment of the County, or others, at any time. Further, Applicant agrees to protect, save and hold harmless, and indemnify the County from and against all liability, loss, damages, personal injuries or expenses suffered by or imposed against the County by reason of the construction, installation or maintenance of the above described improvement.

No perpetual easement or right of way is granted by this instrument and should Applicant's use of said right-of-way interfere with the County's use, or intended use of said right-of-way, Applicant will remove or relocate the same upon demand of the County. Applicant shall pay all costs of such removal or relocation.

This Agreement shall be a covenant running with the above-described real property and shall be binding upon the parties hereto, their heirs, successors, personal representatives, and assigns.

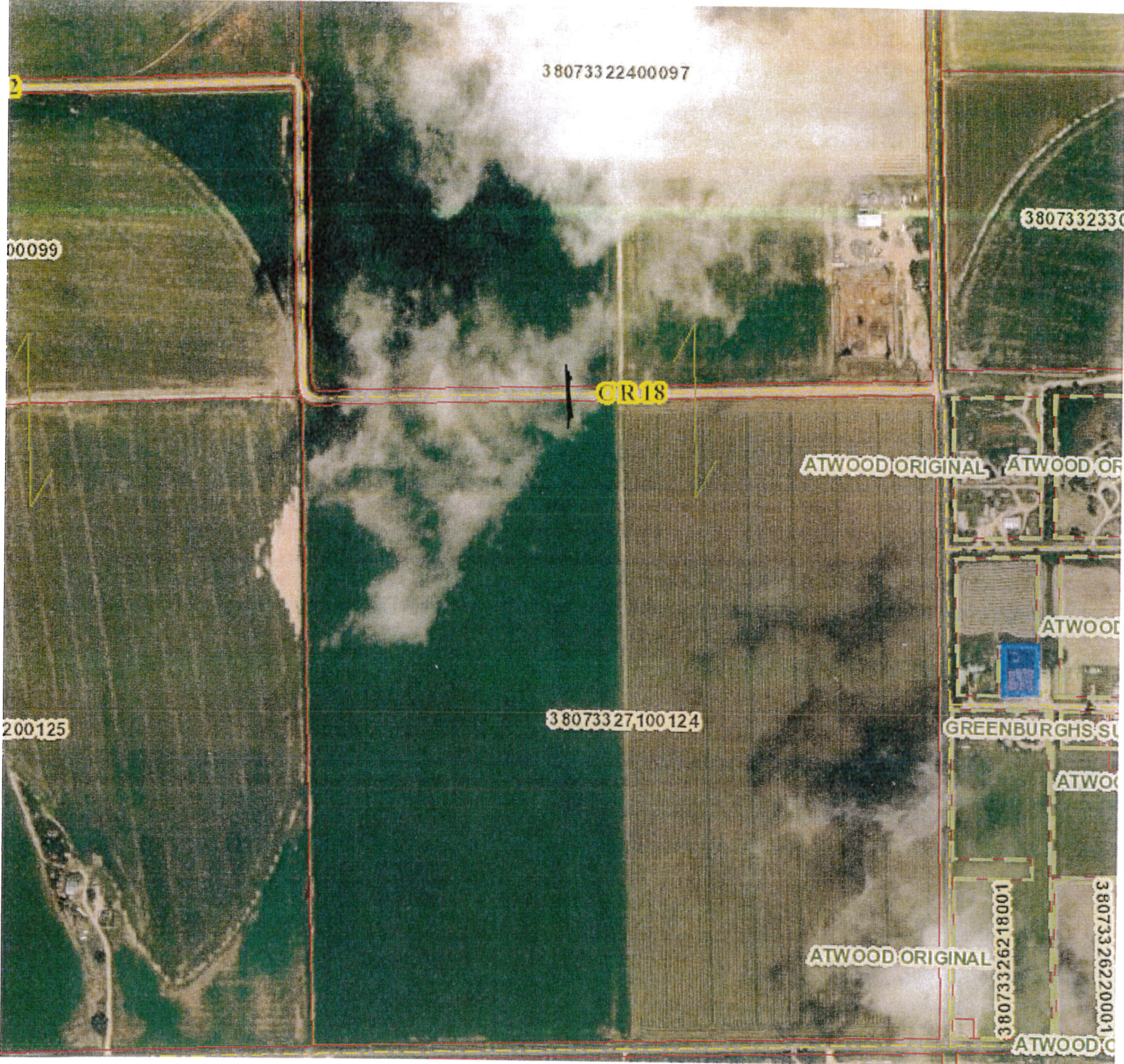

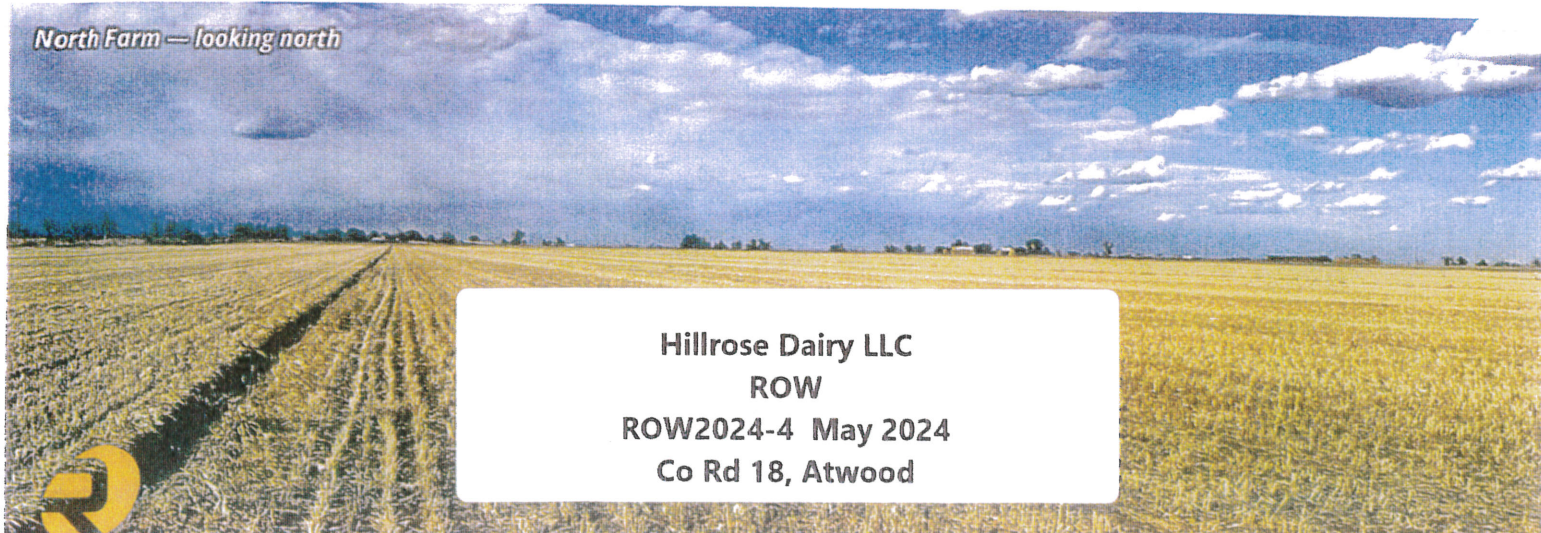

RESOLUTION

No. 2024-15

A resolution of the Board of County Commissioners of Logan County, Colorado, cancelling certain tax sale certificates issued in error as a result of erroneous severed mineral assessments.

WHEREAS, tax liens on certain severed mineral interests were sold for nonpayment of delinquent ad valorem property taxes, as identified in the attached Exhibit A, and subsequently accrued taxes have been paid by the tax lien certificate holders; and

WHEREAS, the tax liens identified in Exhibit A should not have been sold at the tax sale because they involved incorrectly identified and assessed severed mineral interests; and

WHEREAS, the tax lien certificate purchasers have been advised of the errors and may assign their certificates to Logan County in order to receive reimbursement; and

WHEREAS, C.R.S. §39-12-111, provides that when, by mistake or error of the treasurer, county clerk and recorder, or assessor or from double assessment, a tax lien has been sold on land upon which no tax was due at the time, the county shall reimburse the purchaser the amount paid in connection with the purchase of the tax lien, together with interest at a rate equal to the two percentage points above the discount rate or 8% per annum, whichever is greater.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Logan County, Colorado, as follows:

1. The tax lien certificate holders listed on Exhibit A may be reimbursed the purchase price, and subsequent taxes and fees paid, from the various funds to which the tax payments were originally distributed, together with statutory interest pursuant to C.R.S. §39-12-111.
2. The tax sale certificates shown on Exhibit A are hereby cancelled.
3. The taxes assessed on the severed mineral interests for the tax years shown on Exhibit A are hereby cancelled and abated pursuant to C.R.S. §§39-11-107 and 39-10-114 because the mineral interests were incorrectly assessed.

AGREEMENT TO MODIFY AND EXTEND
INTERGOVERNMENTAL AGREEMENT BETWEEN
COUNTY OF LOGAN AND CITY OF STERLING

THIS AGREEMENT is made and entered into effective as of July 1, 2024, by and between the County of Logan, a political subdivision of the State of Colorado, hereinafter called “Logan”, and the City of Sterling, a municipal corporation with a home rule charter, hereinafter called “Sterling.” Logan and Sterling are collectively referred to herein as the “Parties” or may be referred to individually as a “Party”.

The Parties to this agreement entered into an Intergovernmental Agreement, effective July 1, 2019, which provides for the consolidation of all outstanding intergovernmental agreements between the parties into one agreement, with identical terms of duration. The Intergovernmental Agreement was modified effective August 27, 2019 to incorporate one additional intergovernmental agreement relating to Use Tax Collection, which was not included in the original consolidated Intergovernmental Agreement. Together, these agreements are referred to herein as the “Consolidated IGA”, which will terminate according to its own terms on July 1, 2024.

The Parties have since entered into two additional intergovernmental agreements. An agreement for the reciprocal admission of city and county employees to use privileges for the recreation center owned by Sterling and the shooting sports complex owned by Logan is currently in effect and will terminate on July 1, 2024. An agreement for joint use of the Server Platform owned by Sterling was entered into effective June 1, 2023 and will terminate on May 31, 2024.

The Parties desire to incorporate the intergovernmental agreements relating to use privileges for the recreation center and shooting sports complex, and the joint use of the Server Platform, into the Consolidated IGA.

The Parties also wish to extend the termination date of the Consolidated IGA for one additional year.

Therefore, the Parties desire to and do modify the Intergovernmental Agreement in the following respects:

SECTION 2, WHICH READS AS FOLLOWS:

2. This agreement will become effective commencing July 1, 2019 and continue for a five year period. This agreement shall be reviewed and approved by both Logan and Sterling at least 180 days prior to the end of each five year period.

IS DELETED AND THE FOLLOWING SUBSTITUTED:

2. **This agreement will become effective commencing July 1, 2024 and continue for a one year period, ending June 30, 2025.**

SECTIONS 6 AND 7, WHICH READ AS FOLLOWS:

6. **That beginning on July 1, 2019 Logan and Sterling agree to jointly enter into the following programs and/or service:**
 - A. **LOGAN COUNTY AMBULANCE**
 - B. **LOGAN COUNTY LANDFILL**
 - C. **LOGAN COUNTY JAIL**
 - D. **SEWAGE COLLECTION ON COUNTY ROAD 37**
 - E. **SOUTH PLATTE VALLEY REGIONAL TRANSPORTATION AUTHORITY**
 - F. **SUNSET MEMORIAL GARDEN CEMETERY**
 - G. **BUILDING PERMITS**
 - H. **SPECIAL EVENT PERMITS**
 - I. **USE TAX COLLECTION**
7. **That the detail concerning the above-mentioned programs and/or service are addressed in the coinciding Appendixes A-I and shall be considered to be a part of this intergovernmental agreement.**
