REVISIONS TO WORK SESSION AGENDA – CCI Designation Committee.

REVIEW AND APPROVE DEPARTMENT OF HUMAN SERVICES SCHEDULE OF BILLS AND PAYROLL – Shannon Graves met with the Board to review the Logan County Department of Human Services schedule of bills dated October 6, 2020 and Department of Human Services payroll for the period of September 12, 2020 to September 25, 2020. The Board approved as presented.

REVIEW OF BUSINESS MEETING AGENDA –

CCI DESIGNATION COMMITTEE- Commissioner Pelton will be the representative for the CCI Designation Committee.

Cares Act- Still haven't come up with a solution and plan. For documentation. Need to figure out exactly what they need for documentation. Commissioner Bauder thinks the Board needs to review the applications. Jerry said they will not be ready for approval today. Bauder does not think some of the applicants follow the rules. Bauder is requesting that a bill or receipt be provided to show the proper amount requesting assistance for. Money is supposed to be given to those actually affected. It's not supposed to be given to make businesses more whole.

Continuing Small Business Grant Discussion- Commissioner Bauder would like to reveiew round 1 approvals. She wants the Committee to follow the rules that are in place. Need to show receipts and make sure that dates match. Should not be paying for someone's inventory. A spreadsheet is not enough proof to show operational costs.

BUS ROUTE FROM STERLING TO GREELEY- Julie Skeen from Colorado Department of Transportation met with the Board via Zoom. She is interested in getting a bus route in place to go from Sterling to Greeley. The bus is called Bustang. Already has existing routes that started in 2018. CDOT gets oversight about Covid precautions. Money is not coming from local jurisdictions. Money is coming from Federal Transit Administration FTA and FASTER Statewide Program. CDOT partners with NECALG and they will be the operators. Wants to open summer of 2021. The route will start 5 days a week and be observed to see if they can do

more. \$.17 cents per mile. Phone app will allow to buy tickets online. Stops are ADA compliant. Flag stops are not official stops but allow people to get dropped off at a non official stop site. Want to get feedback about stops and schedules. Going to get a survey put in the newspaper for public feedback.

McBride recommends Atwood and Hillrose to be flag stops because their wont be many riders. Merino should be a full stop. The stop in sterling hasn't been decided yet.
