### GENERAL PURPOSE

To perform a variety of semi-skilled work, and operates a variety of equipment in the mowing of roadway right-of-ways for the County Roads.

### SUPERVISION RECEIVED

Works under general supervision of the Assistant Operations Managers and/or Road and Bridge Manager.

### SUPERVISION EXERCISED

None.

### ESSENTIAL FUNCTIONS

- Mows in roadway right-of-ways; removes debris, litter from areas required to be maintained, properly disposes this material.
- Operates equipment and tools associated with assigned job duties.
- Performs routine or operator's maintenance on assigned equipment.
- Complies with safety rules, policies, and procedures. Wears personal protective equipment and clothing, and complies with safe working controls.
- Performs all work duties and activities in accordance with County policies, procedures and safety practices.
- Attends work regularly at the designated place and time.

**Performs related duties as required.**

### TYPICAL QUALIFICATIONS

- Knowledge of designated mowing areas.
- Knowledge of equipment.
- Ability to operate tractor mowers and safety equipment.
- Ability to work in full sun, humidity, heat and rain.
- Ability to work cooperatively and to maintain effective working relationships to accomplish job responsibilities.

### MINIMUM QUALIFICATIONS

1. Education and Experience:
  - A. Graduation from high school or GED equivalent.
  - AND
  - B. Ability to operate a tractor mower.

### SPECIAL QUALIFICATIONS:

1. Must possess a valid Colorado driver's license.

**Essential Physical Abilities:** Sufficient clarity of speech and hearing, which permits the employee to communicate effectively; sufficient vision, which permits the employee to operate equipment and tools; sufficient manual dexterity, which permits the employee to operate equipment and tools; Sufficient personal mobility, which permits the employee to operate equipment; must be able to work in outdoor summer heat.
