

**RECORDER'S NOTES**

**2024 ELECTION DATES:**

January 2, 2024, Tuesday: **Last day to affiliate with a major or minor party in order to run as a party candidate in the primary (either through nomination or petition).**

January 2, 2024, Tuesday: **Last day to register as unaffiliated, in order to be placed in nomination (by petition) as an unaffiliated candidate.**

January 16, 2024, Tuesday: **First day to circulate major party candidate petitions for the Primary Election (Not before third Tuesday in January).** March 19, 2024, Tuesday: **Last day to file major party candidate petitions for the Primary.**

February 5, 2024, Monday: **First day to circulate minor party candidate petitions. (No later than 22 days before the first Tuesday in March)** April 1, 2024, Monday: **Last day to file minor party candidate petitions. (No later than 85 days before primary election)**

February 12, 2024, Monday: **Last day for voters who are affiliated with a political party to change or withdraw their affiliation if they wish to vote in a different party's primary election for the March 5<sup>th</sup> Presidential Primary (Up to and including the 22nd day before the Primary Election)**

February 12, 2024, Monday: **Last day to submit an application to register to vote at a voter registration drive. (No later than 22 days before the election)**

February 12 – February 16, 2024: **Mail delivery ballots will be sent for the Presidential Primary Election (Not sooner than 22 days before the Primary Election)**

February 16, 2024, Friday: **Last day to affiliate with the Republican Party in order to vote in the March 9th Party Precinct Caucuses. (22 days before)**

February 16, 2024, Friday: **Last day to affiliate with the Democratic Party in order to vote in the March 9th Party Precinct Caucuses. (22 days before)**

February 16, 2024, Friday: **Last day to update your voter registration address to participate in the March 9th Republican Party Precinct Caucuses. (Must be a resident of the precinct for 22 days and registered to vote no later than 22 days before the precinct caucus)**

February 16, 2024, Friday: **Last day to update your voter registration address to participate in the March 9th Democratic Party Precinct Caucuses. (Must be a resident of the precinct for 22 days and registered to vote no later than 22 days before the precinct caucus)**

February 26, 2024, Monday: **Last day for an individual to submit a voter registration application and still receive a ballot in the mail. (Through the 8<sup>th</sup> day before an election)**

March 2, 2024, Saturday: **Clerk and Recorder's Office will be open from 8:00 a.m. to 12:00 p.m. for replacement ballots, receipt of ballots or to register to vote.**

**March 5, 2024, Tuesday: PRESIDENTIAL PRIMARY ELECTION (Ballots can be dropped off at the Logan County Courthouse 315 Main Street Suite 3, Sterling, CO or in the 24/7 Drop box located in the parking lot east side 7:00 a.m. to 7:00 p.m.)**

April 19, 2024, Friday: **Last day a write-in candidate may file an Affidavit of Intent for the June 25<sup>th</sup> Primary Election. (By close of business on the 67<sup>th</sup> day before the primary)**

April 26, 2024, Friday: **Last day for an unaffiliated voter to give notice in writing** to the county clerk that he or she wishes to serve as an election judge for the June 25<sup>th</sup> Primary Election. (No later than 60 days before primary election)

May 16, 2024, Thursday: **First day an unaffiliated candidate may circulate or obtain signatures on a petition for nomination for the General Election.** (An unaffiliated candidate may not circulate a petition or gather signatures earlier than 173 days before the General Election) **Last day to file is July 11, 2024. (No more than 117 days before the 2024 General Election)**

June 3, 2024, Monday: **Last day for voters who are affiliated with a political party to change or withdraw their affiliation if they wish to vote in a different party's state primary election** (Up to and including the 22nd day before the Primary Election)

June 3, 2024, Monday: **Last day to submit an application to register to vote at a voter registration drive. (No later than 22 days before the election)**

June 3 – June 7, 2024: **Mail delivery ballots will be sent for the State Primary Election (Not sooner than 22 days before the Primary Election)**

June 17, 2024, Monday: **Last day for an individual to submit a voter registration application and still receive a ballot in the mail.** (Through the 8<sup>th</sup> day before an election)

June 22, 2024, Saturday: **Clerk and Recorder's Office will be open from 8:00 a.m. to 12:00 p.m. for replacement ballots, receipt of ballots or to register to vote.**

**June 25, 2024, Tuesday: PRIMARY ELECTION** (Ballots can be dropped off at the Logan County Courthouse 315 Main Street Suite 3, Sterling, CO or in the 24/7 Drop box located in the parking lot east side 7:00 a.m. to 7:00 p.m.)

July 11, 2024, Thursday: **Last day to file an unaffiliated candidate nomination petition. (117<sup>th</sup> day before the General 2024 Election)**

July 18, 2024, Thursday: **Last day for a write-in candidate to file an Affidavit of Intent for the 2024 General Election. (By the close of business on the 110th day before the 2024 General Election)**

July 26, 2024, Friday: **Last day for a political subdivision to notify the county clerk in writing that it has taken formal action to participate in the 2024 General Election.** (100 days before the 2024 General Election)

October 14– October 18, 2024: **Mail delivery ballots will be sent for the General Election (Not sooner than 22 days before the election)**

October 15, 2024, Tuesday: **Last day to submit an application to register to vote through a voter registration drive. (No later than 22 days before the election)**

October 28, 2024, Monday: **Last day to submit a voter registration application and still receive a ballot in the mail.** (Through eight days before the election)

November 2, 2024, Saturday: **Clerk and Recorder's Office will be open from 8:00 a.m. to 12:00 p.m. for replacement ballots, receipt of ballots or to register to vote.**

**November 5, 2024, Tuesday: GENERAL ELECTION (OPEN) 7:00 a.m. to 7:00 p.m.**  
(Ballots can be dropped off at the Logan County Courthouse 315 Main Street Suite 3, Sterling, CO or  
in the 24/7 Drop Box located in the parking lot east side 7:00 a.m. to 7:00 p.m.)  
**ELECTION DAY ONLY:** (Three Voter Service and Polling Centers will be available); TBD
