2024 Election information:

Deadline next week for the 2024 Election Cycle:

<u>Party Caucuses and Assemblies are conducted by the political parties not the county</u> <u>clerk.</u>

February 14, 2024, Wednesday: Last day to update your voter registration address to participate in the March 7th Republican party precinct caucuses. (Must be a resident of the precinct for 22 days <u>and</u> registered to vote no later than 22 days before the precinct caucus)

February 14, 2024, Wednesday: Last day to affiliate with the Republican Party in order to vote in the March 7th Republican Party Precinct Caucuses. (22 days before the precinct caucuses)

February 16, 2024, Friday: Last day to update your voter registration address to participate in the March 9th Democratic party precinct caucuses. (Must be a resident of the precinct for 22 days <u>and</u> registered to vote no later than 22 days before the precinct caucus)

February 16, 2024, Friday Last day to affiliate with the Democratic Party in order to vote in the March 9th Democratic Party Precinct Caucuses. (22 days before the precinct caucuses)

Presidential Primary Deadline:

February 12, 2024, Monday: Last day for voters who are affiliated with a political party to change or withdraw their affiliation if they wish to vote in a different party's primary election for the March 5th Presidential Primary (up to and including 22nd day before the Primary Election)

Ballots for the March 5, 2024, Presidential Primary Election will be mailed next week February 12 – February 16, 2024. The Presidential Primary Election will be conducted as a <u>Mail Ballot Election</u>. The only Voter Service and Polling Center will be the Logan County Clerk & Recorder's Office 315 Main Street, Suite 3, Sterling, Colorado.

The ballot you receive in the mail is your official ballot and the ballot you need to vote and return to our office for processing. Ballots are mailed to all Active Eligible Voters. As soon as you receive your ballot you may vote the ballot with your choices; sign the return envelope and then return it to the Clerk & Recorder's Office.

All elections will be an all-mail ballot delivery. All voters that are active eligible electors will be mailed a ballot to the address on file.

<u>REMEMBER</u>: Logan County Drop Box can be used for Voted Ballots, Motor Vehicle Renewals or Tax Payments or any other correspondence that needs to get to a county office at the Courthouse.

BallotTrax is a free service for Logan County Voters that allows you to track the status of your ballot online, as well as receive messages by text, phone or email when your ballot has been sent to you and received by our Elections Division.
