<u>One week until June 25, 2024, Election.</u> Have you returned your ballot to the Logan County Clerk's office? We appreciate receiving voted ballots early so our election judges can start processing. The earlier ballots are returned, the earlier election night results can be released.

- Drop your ballot off at the Logan County Clerk & Recorder's Office at 315 Main Street, Sterling, CO 80751, located on the first floor, northwest corner of the Courthouse or,
- Drop your ballot in the 24/7 drop box located in the Courthouse parking lot (Ash Street entrance) east side of the parking area (no postage necessary).
- It is too late to mail your ballot do not mail after June 18, 2024.

REMEMBER: POSTMARKS DO NOT COUNT. Your ballot must be in the possession of the Logan County Clerk and Recorder by 7:00 P.M. June 25, 2024.

<u>DISQUALIFIED CANDIDATE</u>: The following candidate has been disqualified from the June 25, 2024, Election. Under C.R.S. 1-4-1001 any votes cast for the candidate listed are invalid and shall not count:

• State House District 63 – Charles Alvarado, Democratic party
