<sup>4</sup>A Conditional Use Permit is not required for the construction of water and/or sewage transmission lines in Commissioner approved subdivision. (See August 3, 1977 Resolution)

<sup>5</sup>For each instance, the water and/or sanitation district shall provide plot plans showing the proposed installation and its relationship to any nearby property. The Board shall prescribe conditions for each installation in order to protect adjacent properties.
